IT IS AGREED AS FOLLOWS: The above-named Seller will sell, and the above named Purchaser will buy the dog (dog name) detailed below at the price listed. Dog name has no known health conditions at the time of sale and will/will not be microchipped prior to leaving the Seller. Dog name is guaranteed to be a purebred, gender, color Labrador Retriever.

The Purchaser agrees to and understands the following conditions:

a. Insert any training that has been done/will be done and the terms of said training

b. Should anything occur within this placement that will necessitate the relocation/rehoming of dog name, the Purchaser agrees to notify the Seller for the right of first refusal to take dog name back or to assist in placing dog name in a new location. At no time shall this dog be given to a Humane Society or Animal Shelter.

c. Dog name has been purchased as a pet/working animal and shall not be bred without written approval from the Seller. Dog name is to be neutered/spayed when he/she reaches an appropriate age, which is left to the discretion of the purchaser. AKC paperwork for dog name shall be held by the Seller until proof of neuter is received. At that time, the Seller shall sign off on dog name's AKC registration.

d. Insert any health testing that has been done on dog or dog's parents and any health guarantees.

e. Insert any information about preventatives administered

f. The Seller is not aware of any existing medical conditions dog name may have and he is believed to be in good health. The Seller does not express nor imply any guarantees regarding the purchase of dog name. He is being sold as is.

g.The Seller will continue to provide all care to dog name until he/she leaves the Seller's possession, which includes veterinary care of any kind. Dog name will also have a current rabies vaccine at the time of sale and a recent veterinary check.

h.The Seller has the right to terminate this agreement at any time should they feel this placement is not in the best interest of dog name or the Sellers themselves. This agreement will also be terminated if at any time while in the Seller's care dog name is found to have any medical conditions or unhealthy/unfit for sale. If the Seller terminates this agreement, all money paid by the purchaser shall be returned within 14 days of termination.

i. The purchaser has the right to terminate this agreement at any time for any reason, including changing their mind. If the purchaser terminates this agreement, all money paid to the Seller by the Purchaser shall be returned within 14 days of termination.

j.The purchaser agrees to provide dog name a safe environment with adequate care. Dog name is to be a loved member of the family and shall not be neglected or abused, or he shall be returned to the Seller immediately.
